# Developments in the outbreak

- As of 05 May 2020, the total number of coronavirus (COVID-19) cases in Victoria is 1,423, an increase of 17 since yesterday.
- The new confirmed cases include eleven new cases of COVID-19 at a Melbourne meat processing facility, taking the total number of cases in this cluster to 45. The department is working closely with the company, which agreed to close their facility for 14 days as a precaution to ensure all required steps are taken, including a thorough cleaning process.
- 12 people are in hospital, including 6 people in intensive care. 18 people have died. There are currently 81 active cases in Victoria.
- 143 cases have an unknown source of infection, an increase of 1 since yesterday.
- 1,311 people have recovered. To date, almost 152,000 tests have been performed in Victoria, with many more samples still being processed following high testing blitz numbers over the weekend.
- Of the total 1,423 cases, there have been 1,166 in metropolitan Melbourne and 218 in regional Victoria. A number of cases remain under investigation.

- There have been 169 confirmed cases in healthcare workers, an increase of 1 since yesterday.
- Up-to-date <u>epidemiological data</u> is available on our website.

#### Current advice to clinicians

- A major COVID-19 testing blitz is currently taking place across Victoria, to better understand
  how the virus is spreading in the community. Every effort will be made to actively find cases of
  COVID-19.
- Widespread testing is strongly encouraged at the present time. Practitioners are encouraged to test any patients who meet the clinical criteria below:

Fever OR chills in the absence of an alternative diagnosis that explains the clinical presentation\*

OR

Acute respiratory infection (e.g. cough, sore throat, shortness of breath, runny nose or anosmia)

Note: In addition, testing is recommended for people with new onset of other clinical symptoms consistent with COVID-19\*\* AND who are close contacts of a confirmed case of COVID-19; who have returned from overseas in the past 14 days; or who are healthcare or aged care workers.

\*Clinical discretion applies including consideration of the potential for co-infection (e.g. concurrent infection with SARS-CoV-2 and influenza)

\*\*headache, myalgia, stuffy nose, nausea, vomiting, diarrhoea

- If referring your patients for COVID-19 testing, a list of testing locations can be found on the getting tested for coronavirus page.
- Workers without symptoms in hospitals and other facilities with vulnerable residents may be asked to voluntarily participate in sample testing to inform disease surveillance activity.
   Advice will be forthcoming on this.

# Key messages for the community

- If you have any of the symptoms of coronavirus, you should seek medical advice and get tested. To get further advice, call your GP or the 24-hour coronavirus hotline 1800 675 398.
- The rules are clear Stay home. Protect the health system. Save lives.
- There are only four reasons to leave home:
  - o shopping for what you need food and essential supplies
  - o medical, care or compassionate needs
  - exercise in compliance with the public gathering requirements
  - work and study if you can't work or learn remotely.

# Current directions arising from the declared state of emergency

The State of Emergency in Victoria has been extended until midnight 11 May 2020.

The current directions remain in place and include: staying at home, restrictions on particular activities, detention, restrictions on airports and cruise ships, aged care, hospitals and isolation for people diagnosed with COVID-19
