# Coronavirus COVID-19 daily update

### What's new?

## Developments in the outbreak

- As of 14 May 2020, the total number of coronavirus (COVID-19) cases in Victoria is 1,523, an increase of 9 since yesterday.
- The new confirmed cases include 2 new cases of coronavirus (COVID-19) at a Melbourne meat processing facility, taking the total number of cases in this cluster to 90.
- 164 cases have an unknown source of infection, with no change since yesterday.
- 9 people are in hospital, including 6 people in intensive care. 18 people have died.
- There are currently 119 active cases in Victoria, and 1,385 people have recovered
- To date, over 289,000 tests have been performed in Victoria, with many more samples still being processed.
- Of the total 1,523 cases, there have been 1,259 in metropolitan Melbourne and 226 in regional Victoria. A number of cases remain under investigation.
- There have been 177 confirmed cases in healthcare workers, with no change since yesterday's report.

- Up-to-date <u>epidemiological data</u> is available on our website.
- Victoria's state of emergency has been extended until 11.59pm on Sunday 31 May. New Directions were issued at 11.59pm Tuesday 12 May with some restrictions eased.

#### Current advice to clinicians

- The Commonwealth Department of Health has engaged Sonic Healthcare (Melbourne Pathology in Victoria) to provide a rapid in-reach sample collection and testing pathology service for all residential aged care facilities.
- The service will:
  - Receive and prioritise requests for COVID-19 testing of residents and/or staff of a residential aged care facility
  - Arrange for a specialised COVID-19 pathology collector to attend a facility and return the sample to the laboratory for immediate testing
  - Provide results by phone to the referring doctor and registered nurse attached to the facility within 24 hours for metropolitan areas or 48 hours for regional areas, and
  - If a result is positive, send a specialised COVID-19 collection team to collect samples from all staff and residents.
- There is a dedicated toll-free number -1800 570 573 operating from 8am to 6pm that all residential aged care facilities can contact to arrange priority testing for residents and staff.
- Due to the high volume of tests being processed, results may take longer than usual, up to 5 days
- Practitioners are encouraged to test any patients who meet the clinical criteria below:

Fever OR chills in the absence of an alternative diagnosis that explains the clinical presentation  $\!\!\!^*$  OR

Acute respiratory infection (e.g. cough, sore throat, shortness of breath, runny nose or anosmia)

Note: In addition, testing is recommended for people with new onset of other clinical symptoms consistent with COVID-19\*\* AND who are close contacts of a confirmed case of COVID-19; who have returned from overseas in the past 14 days; or who are healthcare or aged care workers.

\*Clinical discretion applies including consideration of the potential for co-infection (e.g. concurrent infection with SARS-CoV-2 and influenza)

\*\*headache, myalgia, stuffy nose, nausea, vomiting, diarrhoea

# Key messages for the community

- Victoria's State of Emergency has been extended to 31 May, but some restrictions have been eased.
- There are now five reasons to leave your home:
  - o Shopping for food and supplies that you need
  - o Care and caregiving
  - Exercise and outdoor recreation
  - Work and education if you can't do it from home
  - Visiting friends and family if you really need to.

- Staying apart keeps protecting the health system and saves lives.
- Protect yourself from coronavirus (COVID-19) by washing your hands regularly with soap and water; and try not to touch your face, including your eyes, nose or mouth.
