MINUTES OF MEETING REGARDING QUARINTINE FACILITY FOR COVID-19 HELD ON 11/03/2020 AT 4.30 P.M.

A meeting was convened by the Collector (North) in the conference hall of the Collectorate of North Goa District on 11/03/2020 at 04.30 p.m. to discuss the future course of action to be taken on COVID-2019 and the Containment Plan for novel Corona virus disease 2019 of the Ministry of Health & Family Welfare, Govt. of India. The list of the Officers/Officials present for the meeting is enclosed herewith.

At the outset, the Additional Collector-I, welcomed all present for the meeting and discussed current situation on Corona Virus and informed that the 03 cases have been identified in Goa and requested all the Stakeholders to stay cautious of the situation and to take the necessary precautions on the same. It was informed that the Ministry of Health and Family Welfare, Government of India, has come up with a Containment Plan on novel corona virus disease, 2019 (COVID-19) The same has been mailed to all the stakeholder for information and necessary action.

Further the Collector, North informed that accommodation facilities have been indentified in all the talukas of North Goa to be used as quarantine places in case of a major outbreak in Goa that can accommodate 50 males and 50 females. The Mamlatdars were directed to keep in readiness 100 beds with for each quarantine facility which shall be requisitioned when required. The Goa waste management committee was directed to keep in readiness seven mobile toilets for each quarantine facility.

Action by:- 1) All Taluka Mamlatdar's of North Goa District.

2) The Goa waste management committee.

The disease can spread through the air Corona virus shows symptoms within 14 to 21 days. Iran, Italy and China death rates are very high and in neighbouring States of Karnataka & Maharastra have been detected with Positive cases.

Doctor Savita Naik, Epidemiologist North Goa District gave a briefing on the virus and informed, if any one with bad cough flu should be admitted at GMC for

treatment. Blood samples were sent to Kasturbha medicals Mumbai which was shown negative. 3 Screens has been placed at the airport displaying about the symptoms of corona virus and in future they have decided to Screen at KTC bus stands, Railway stations, etc. Information on the data in this regard was informed.

It was directed that a Nodal Officers from each line Department should be appointed and informed to this office.
