

Minutes of Meeting of the State Executive Committee held in the Forest Bhavan, on 17th April 2020

On 17/04/2020, a meeting of State Executive Committee (SEC) was held under the Chairmanship of Chief Secretary (also Principal Secretary, PWD), Goa and the following other members of the SEC also attended:

1. Shri Puneet Goel, Principal Secretary, Science and Technology
2. Shri S.K. Bhandari, Secretary, Transport
3. Shri Sanjay Kumar, Secretary Revenue, Member Secretary, SEC & SDMA

The SEC has gone through the reports on Law & Order, Trucks Movement, Relief & Shelters, and Covid Status Report (copy attached).

The other officers (as per the list Annexed) also attended the meeting as special invitees:

After deliberation on the current situation, the SEC noted and decided the following:

1. **Status of COVID19:** Secretary Health informed that no new Covid-19 case has been detected after 3rd April 2020. As on date, Goa has seven positive cases of Covid-19, out of which six patients have recovered and have been shifted to a Quarantine facility outside. 61 tests (43 at Asilo and SDH, Ponda, and 18 at GMC) done during the 24 hours on SARI/ILI patients for Covid were negative. The SEC noted with caution that Goa had not yet faced any community transmission.
2. Secretary, Health informed that the department has been able to procure 1,000 Thermal guns. The supply is most likely to reach Goa by day after tomorrow. The departments were asked to share their demand for Thermal Guns with the Health department. Secretary Health indicated the demand for additional 1,000 Thermal guns. Therefore, the SEC agreed to purchase 2,000 Thermal guns for the use by State authorities.
3. Secretary, Health also informed that Goa has got additional 4,000 Rapid testing kits from Govt of India, for screening/rapid testing.
4. The SEC directed that the guidelines issued by MHA are to be strictly adhered to. In case of any doubt on the applicability of the revised guidelines issued by the MHA on 15/04/2020, and its addendum dated 16/04/2020, under the Disaster Management Act, 2005, the concerned authorities may seek clarification from the Collectors.
5. Earlier during the day, the Principal Secretary, Science and Technology held a series of meetings (minutes of 3 meetings attached) with different stakeholders to draw a mechanism for the issuance of permission for the functioning of industrial units in various industrial estates and other permitted category of activities from 20 Apr, 2020. He briefed the SEC, and after discussion the SEC agreed with the

recommendations and directed all authorities to act on them accordingly. The SEC also reiterated that the instructions/guidelines issued by the MHA are to be strictly adhered to by the industrial establishments and others. Any violation of the MHA's guidelines may result in the withdrawal of the permission and may attract other provisions of law.

6. The SEC noted the directions of MHA for compulsory use of face cover by all when in public spaces and workplace from 20 April, 2020. Hon'ble CM may be requested to issue an appeal to all residents of Goa for wearing a cloth mask/face-cover from 20th April. The SEC advised the use of washable cloth mask/face cover. The disposable masks are to be handled as a bio-medical waste. Improper disposal of such disposal masks is an offence and all authorities should enforce the regulations accordingly.
7. Secretary Health informed that all RMDs and Sub-centres have been operationalised, as planned. The SEC asked Collectors to assess the utilisation of paramedics deployed on borders, for rationalising their deployment, so that some of them could be shifted back to for duty at the RMDs/Sub-centres.
8. Nodal Officer (Foreginors) informed that tonight about 300 Russian would be leaving from Goa airport by a special ferry flight.
9. The SEC asked the Secretary, Tourism to work out a mechanism for pooling of tourists in some limited hotels, as there are tourists spread across Goa in different hotels in small numbers. If they can be brought together in a few hotels it would ease operations for the hotels.

10. Quarantine Facilities for Seafarers:

- a. Collectors have started the inspection of the Hotels, which were earlier identified by the Tourism department, to be used as paid Quarantine Facilities. The Collectors assured to submit their report by the evening.
 - b. Secretary Tourism will thereafter discuss with Secretary Health to finalise the list submitted by the Collectors..
 - c. Secretary, Education was also asked to prepare a list of suitable hostel facilities available with the Educational Institutions in Goa, which can be used for Quarantine purposes.
 - d. Collectors should also identify availability of similar rooms with religious organisations such as Churches, Temples, etc. to assess their number and suitability.
11. The SEC decided that there are a few complaints regarding clandestine sale of liquor. Commissioner, Excise was directed to seal the premises/godowns of wholesalers till the lockdown period. If any complaint against retailers is received, similar action be taken against them as per law.
 12. Commissioner, Excise informed that liquor manufacturers have received requisite permission to sell sanitisers through grocery shops.




13. Secretary, Civil Supply informed the supply of essential goods is normal. She also informed that Groceries-on-Wheels was sent to Surla, Valpoi to meet the local demand as earlier advised by the District Observer.
14. Secretary, Cooperative Societies informed that Government has issued necessary directions to start the Citizen Cooperative Societies, as permitted by MHA guidelines issued on 16 Apr, 2020
15. Director, Panchayat informed that pre-monsoon and disinfection work is going on in all Panchayats. The department has also issued instructions for use of Rs. 25,000 by each of the 105 weaker panchayats, to help them carry out immediate relief work.
16. DMA informed that the Cuncoim Municipal Council members have to statutorily elect a new Chairperson, and Canacona Municipal Council is to pass its annual budget to incur expenditure. The SEC noted that these are statutory duties, and thus it's essential for them to carry out these activities, which are time bound. However, DMA should ensure that the public does not attend such meetings and the Council follows the norms of social distancing, use of face covers/masks and other norms of safety.
17. DMA informed that the requirement for cloth masks for the Government Departments will be met by GSUDA under NULM. The SEC was informed that masks are now available in the market.
18. The SEC was informed by Collector, North-Goa that the Government has sanctioned an expenditure for purchase of Rapid Testing kits out of DMF with North District. Of the 5 purchased, 2 have been installed at Ponda Sub District Office, which is administratively under South Goa District. The SEC directed the DMF South may be used to reimburse the expenditure undertaken by DMF North for SDH, Ponda.
19. The Nodal Officer for Quarantine facilities informed that 11 individuals were in the quarantine facility at Mayem Residency, and five at Acron Homes at Candolim. He is visiting these facilities regularly.
20. CE(Electricity) informed that the electricity supply in the state is normal. IGP informed of some disruptions in Baina, as per some social media posts. The SEC asked the CE (Electricity) to verify the issue and take suitable action.
21. PCE(PWD) informed that water supply in the State is normal. The SEC expressed its displeasure on the wrong information provided by the PCE yesterday regarding the restoration of normal supply at Tuem, which was confirmed by the Incident Commander. The concerned Executive Engineer and Assistant Engineer were called for the SEC meeting today, and were reprimanded for furnishing wrong information, and were warned of serious action if such action is repeated.



22. PCCF requested the SEC to replace Dr N Palanikant, DCF Executive Magistrate cum Incident Commander, Mormugao with Ms Yashoda Prakash, DCF. The SEC directed the Collector (South) and SS(Home) to examine the issue for necessary orders.
23. Director, IT presented the module of web-based service for monitoring the movement of goods vehicles after doing a pilot, as directed by SEC on the previous day. After presentation and detailed discussion, the SEC gave the go ahead with some changes, and decided to review the functioning again on coming Wednesday.
24. The SEC reiterated that the MHA's guidelines are to be complied by all the establishments. All authorities should strictly enforce and ensure compliance of these instructions/directions.

Committee also conveyed to all concerned that as per MHA orders, any person violating these containment measures or not complying with the above directions will be liable to be proceeded against as per the provisions of Section 51 to 60 of the Disaster Management Act, 2005, besides legal action u/s 188 of the IPC.
