Haryana Villagers General Health Check-up Scheme (HVGHCS) Daily Bulletin (Dated: 04.07.2021)

- The scheme was initiated from May 15, 2021 & villages with high COVID load were taken on priority. All the villages of the districts have been screened once and rescreening of all the villages having more than 5% Rapid Antigen Test (RAT) positivity has been completed on 14/06/2021.
- > The initial screening was carried out from 15 May to 8 June, 2021.

The data of initial screening is given below:

- Total persons screened 1,73,79,228.
- Total persons detected for Influenza like illness (ILI) 1,10,928.
- Total persons tested for RAT 1,31,635 out of these 3,744 were positive.
- Total persons tested RT-PCR 65,856 out of these 1,420 were positive.
- The maximum daily RAT positivity rate was 5.47% on 19 May, 2021 which gradually dropped down to 0% on 8 June 2021.
- The spread of pandemic was curtailed in rural areas effectively.
- > The rescreening was carried out from 01 June to 14 June, 2021.

The data of rescreening is given below:

- Total persons rescreened 13,22,058.
- Total persons tested for RAT 19,925 out of these 78 were positive.
- Total persons tested RT-PCR 14,468 out of these 12 were positive.
- > Monitoring of Home Isolation Kits Distributed as on 4<sup>th</sup> July 2021: 36183

#### Major Activities undertaken by the State of Harvana to control the spread of COVID-19

- Department of Health fixed the per day upper cap of COVID treatment charges in all private hospitals through order dated 25.06.2020. The rates for isolation beds (Rs. 8, 000 per day for Non- NABH Hospitals, Rs. 10, 000 per day for JCI/ NABH Hospitals), ICU Beds without Ventilators (Rs. 13, 000 per day for Non- NABH Hospitals, Rs. 15, 000 per day for JCI/ NABH Hospitals), ICU Beds with Ventilators (Rs. 15, 000 per day for Non- NABH Hospitals, Rs. 18, 000 per day for JCI/ NABH Hospitals).
- State Government has fixed the Rates/ Charges for different type of COVID 19 testing as below:-
  - CBNAAT testing- 2400/-. 1.
  - 2. True NAT Testing- 1250/-
  - 3. Samples collected at private hospitals/ labs and their designated collection centers - 450/-
  - 4. Samples collected through home visits - 650/-
  - 5. Rapid Antigen Testing-350/-
  - IgG based ELISA Testing-250/-6.
- The Government of Haryana has fixed the upper limited of lab test in patients of COVID-19/ post-COVID sequelae, as tabulated below:-

- Total 4529 number of Plasma Units collected from COVID 19 recovered patients till date and 3070 COVID 19 Patients given Plasma Therapy treatment till date.
- Control Room -cum- Helpline of 30 lines has been made operational at Panchkula. Services of tele-medicines are being provided through helpline. The helpline nos. are 8558893911, 1075 and 108 (Ambulance Services) available for 24 X 7.
- The State Government notified 'The Haryana Government Epidemic, COVID-19 Regulations, 2020' under the Epidemic Disease Act 1897 on 11th March 2020.
- Nineteen Government Labs, one each at PGIMS, Rohtak (capacity 3000 sample per day) and BPS Khanpur Kalan (2000 sample per day), ESIC Medical College Faridabad (2000 sample per day), Kalpna Chawla Medical College Karnal (2000 sample per day), Civil Hospital, Gurugram (1800 sample per day), Civil Hospital, Panchkula (2000 sample per day), Command Hospital (150 sample per day), SHKMGMC, Nalhar (2000 samples per day), TRANSATIONAL Lab, Faridabad (500 sample per day), Civil Hospital, Ambala (2500 sample per day), MAMC Agroha, Hisar (1500 sample per day), Civil Hospital, Sirsa (1500 sample per day), Civil Hospital Rewari (1500 sample per day), CHC UCHANA JIND (900 sample per day), Civil Hospital, Panipat (1500 sample per day), IMTECH, CSIR, Chandigarh (200 sample per day), Civil Hospital, Yamunanagar (2500 sample per day) and Civil Hospital, Bhiwani (1000 sample per day) District Molecular Lab, Faridabad(900 sample per day) are for doing test for COVID-19 and Twenty Four Private Labs at CORE Diagnostics (5000 sample per day), Modern Diagnostic & Research Centre Lab, Gurugram (2500 sample per day), Path Kind Lab, Gurugram (8000 sample per day), Dr. Lal Path Lab (3000 sample per day), SGT Gurugram (1500 sample per day), Star Imaging & Path (P) Ltd (1500 sample per day), Prognosis Laboratories (2000 sample per day), Atulaya Healthcare, Sector-11-A, Chandigarh (4900 sample per day), MolQ lab, Gurugram (1200 sample per day), GEN-X Diagnostics, Delhi (1000 sample per day), Molecular Lab, Adesh Medical College and Hospital, Kurukshetra (2500 sample per day), AAL Research and Solution Pvt. Ltd., Panchkula (1500 sample per day), Spice Healthcare Pvt. Ltd., Gurugram (25000 sample per day), Pathline Labs Private Limited, Sec-63, Noida, UP (3500 sample per day), Life Cell International Pvt. Ltd., Gurugram (3000 sample per day), Hindustan Wellness Lab, Gurugram (6000 sample per day), FICCI Research and Analysis Centre, New Delhi (700 sample per day), CNC PathlabJhandewalla, Delhi (2500 sample per day), NC Medical College, Israna, Paniath (750 sample per day), World Medical College (500 sample per day), AL FALAH Medical College Faridabad (400 sample per day) and Genestrings Diagnostic Centre, Delhi (4000 sample per day), Mangalam Diagnostics, Hisar (2000 sample per day), Bhasin Path Lab, Delhi(1500 sample per day), are doing test for COVID-19.
- More than 87.20 lac persons have already downloaded AarogyaSetu App in Haryana.
- More than 30 Mobile Health Teams have already been formed to check health status regarding SARI, ILI etc.
- Haryana has 41, 134 bedded quarantine facilities in Dedicated COVID Care Centers and 19,582 Beds are available in Dedicated COVID Hospitals and in Dedicated COVID Health Centers.
- Department of Ayush has distributed immunity boosting medicines to more than 12.19 lac persons in containment zones.
