Major Activities undertaken by the State of Haryana to control the spread of COVID-19

- Department of Health fixed the per day upper cap of COVID treatment charges in all private hospitals through order dated 25.06.2020. The rates for isolation beds (Rs. 8, 000 per day for Non- NABH Hospitals, Rs. 10, 000 per day for JCI/ NABH Hospitals), ICU Beds without Ventilators (Rs. 13, 000 per day for Non- NABH Hospitals, Rs. 15, 000 per day for JCI/ NABH Hospitals), ICU Beds with Ventilators (Rs. 15, 000 per day for Non- NABH Hospitals, Rs. 18, 000 per day for JCI/ NABH Hospitals).
- State Government has fixed the Rates/ Charges for different type of COVID 19 testing as below:-
 1. CBNAAT testing- 2400/-.
 2. True NAT Testing- 1250/-
 3. Samples collected at private hospitals/ labs and their designated collection centers - 299/-
 4. Samples collected through home visits - 499/-
 5. Rapid Antigen Testing-350/-
 6. IgG based ELISA Testing-250/-

- The Government of Haryana has fixed the upper limited of lab test in patients of COVID-19/ post-COVID sequelae, as tabulated below:-

- Haryana Village General Health Checkup Scheme: The scheme was initiated from May 15, 2021 & villages with high COVID load were taken on priority and Rapid Antigen Testing (RAT) was the main stay of screening. Till date, total 1,73,79,228 were screened and 1,10,928 cases of ILI were detected and 5,164 positive cases were diagnosed, isolated and treated to prevent the spread of disease. The villages with positivity more than 5% were re-screened. Out of 13,22,058 people re-screened, 90 positive cases were detected and treated to effectively curtail the spread.
- Total 3053 number of Plasma Units collected from COVID 19 recovered patients till date and 1923 COVID 19 Patients given Plasma Therapy treatment till date.
- Control Room –cum- Helpline of 30 lines has been made operational at Panchkula. Services of tele-medicines are being provided through helpline. The helpline nos. are 8558893911, 1075 and 108 (Ambulance Services) available for 24 X 7.
- The State Government notified ‘The Haryana Government Epidemic, COVID-19 Regulations, 2020’ under the Epidemic Disease Act 1897 on 11th March 2020.

Ltd., Panchkula (1500 sample per day), Spice Healthcare Pvt. - More than 87.96 lac persons have already downloaded AarogyaSetu App in Haryana.
- More than 30 Mobile Health Teams have already been formed to check health status regarding SARI, ILI etc.
- Haryana has 41,135 bedded quarantine facilities in Dedicated COVID Care Centers and 20,095 Beds are available in Dedicated COVID Hospitals and in Dedicated COVID Health Centers.
- Department of Ayush has distributed immunity boosting medicines to more than 12.19 lac persons in containment zones.
- Monitoring of Home Isolation Kits Distributed as on 17th July 2021: 36575 (Details provided by National Health Mission, Haryana)
