29 new deaths and 137 new cases confirmed

- the Health Protection Surveillance Centre (HPSC) has been notified that 29 people diagnosed with COVID-19 in Ireland have died - bringing the total deaths to 1,403
  - 137 additional cases of COVID-19 have been confirmed in Ireland
  - there are now 22,385 confirmed cases of COVID-19 in Ireland
