## The latest news as of 6pm on Monday 11 May 2020

15 new deaths and 139 new cases confirmed:

- the Health Protection Surveillance Centre (HPSC) has been notified that 15 people diagnosed with COVID-19 in Ireland have died - bringing the total deaths to 1,467
- 139 additional cases of COVID-19 have been confirmed in Ireland
- there are now 23,135 confirmed cases of COVID-19 in Ireland
