The latest news as of 6pm on Wednesday 13 May 2020

10 new deaths and 159 new cases confirmed:

- the Health Protection Surveillance Centre (HPSC) has been notified that 10 people diagnosed with COVID-19 in Ireland have died - bringing the total deaths to 1,497
- 159 additional cases of COVID-19 have been confirmed in Ireland
- there are now 23,401 confirmed cases of COVID-19 in Ireland
