The latest news as of 6pm on Thursday 14 May 2020

10 deaths and 426 cases confirmed:

- the Health Protection Surveillance Centre (HPSC) has been notified that 10 people diagnosed with COVID-19 in Ireland have died - bringing the total deaths to 1,506
- 426 additional cases of COVID-19 have been confirmed in Ireland. 223 of the confirmed cases reported today are historical cases which have been managed clinically but only recently notified to the HPSC
- there have now been 23,827 confirmed cases of COVID-19 in Ireland
