The latest news as of 6pm on Saturday 16 May

15 deaths and 92 cases confirmed:

- the Health Protection Surveillance Centre (HPSC) has been notified that 15 people diagnosed with COVID-19 in Ireland have died - bringing the total deaths to 1,533
- 92 additional cases of COVID-19 have been confirmed in Ireland
- there have now been 24,048 confirmed cases of COVID-19 in Ireland
