The latest news as of 5.30pm on Monday 18 May

4 deaths and 88 new cases confirmed:

- the Health Protection Surveillance Centre (HPSC) has been notified that 4 people diagnosed with COVID-19 in Ireland have died - bringing the total deaths to 1,547
- 88 additional cases of COVID-19 have been confirmed in Ireland
- there have now been 24,200 confirmed cases of COVID-19 in Ireland
