16 deaths and 51 new cases confirmed:

- the Health Protection Surveillance Centre (HPSC) has been notified that 16 people diagnosed with COVID-19 in Ireland have died - bringing the total deaths to 1,561
- 51 additional cases of COVID-19 have been confirmed in Ireland
- there have now been 24,251 confirmed cases of COVID-19 in Ireland

Update on testing

As of midnight Monday 18 May, 295,626 tests have been carried out.

Over the past week, 36,818 tests were carried out. Of these, 932 were positive, giving a positivity rate of 2.5%.
