11 deaths and 115 new cases confirmed:

- the Health Protection Surveillance Centre (HPSC) has been notified that 11 people diagnosed with COVID-19 in Ireland have died - bringing the total deaths to 1,592 (2 have been denotified)
- 115 additional cases of COVID-19 have been confirmed in Ireland
- there have now been 24,506 confirmed cases of COVID-19 in Ireland


