- the Health Protection Surveillance Centre (HPSC) has been notified that 8 people diagnosed with COVID-19 in Ireland have died bringing the total deaths to 1,658
- 10 additional cases of COVID-19 have been confirmed
- there have now been 25,066 confirmed cases of COVID-19 in Ireland

As of midnight Monday 1 June, 348,416 tests have been carried out.

Over the past week, 22,621 tests were carried out. Of these, 389 were positive, giving a positivity rate of 1.7%.
