3 deaths and 47 new cases confirmed:

- the Health Protection Surveillance Centre (HPSC) has been notified that 3 people diagnosed with COVID-19 in Ireland have died - bringing the total deaths to 1,659 (2 deaths have been denotified)
- 47 additional cases of COVID-19 have been confirmed
- there have now been 25,111 confirmed cases of COVID-19 in Ireland
