- there have been no additional deaths reported to the Health Protection Surveillance Centre (HPSC) in the past 24 hours
- the total number of COVID-19 related deaths in Ireland is 1,706
- 18 additional cases of COVID-19 have been confirmed
- there have now been 25,321 confirmed cases of COVID-19 in Ireland
