The latest news as of 5.15pm on Tuesday 16 June

3 deaths and 14 cases confirmed:

- the Health Protection Surveillance Centre (HPSC) has been notified that 3 people diagnosed with COVID-19 in Ireland have died - bringing the total deaths to 1,709
- 18 additional cases of COVID-19 have been confirmed
- there have now been 25,334 confirmed cases of COVID-19 in Ireland
- validation of data at the HPSC has resulted in the denotification of 1 confirmed case. The figure of 25,334 confirmed cases reflects this
