3 deaths and 8 cases confirmed:

- the Health Protection Surveillance Centre (HPSC) has been notified that 3 people diagnosed with COVID-19 in Ireland have died - bringing the total deaths to 1,710
- validation of data at the HPSC has resulted in the denotification of 2 deaths. The figure of 1,710 reflects this
- 8 additional cases of COVID-19 have been confirmed
- there have now been 25,341 confirmed cases of COVID-19 in Ireland
- validation of data at the HPSC has resulted in the denotification of 1 confirmed case. The figure of 25,341 confirmed cases reflects this
