The latest news as of 5.30pm on Friday 19 June

2 deaths and 13 cases confirmed:

- the Health Protection Surveillance Centre (HPSC) has been notified that 2 people diagnosed with COVID-19 in Ireland have died - bringing the total deaths to 1,714
- validation of data at the HPSC has resulted in the denotification of 2 deaths. The figure of 1,714 deaths reflects this
- 13 additional cases of COVID-19 have been confirmed
- there have now been 25,368 confirmed cases of COVID-19 in Ireland
