6 cases confirmed:

- the Health Protection Surveillance Centre (HPSC) has not been notified of any COVID-19 deaths in the last 24 hours. Total deaths remain at 1,715
- 6 additional cases of COVID-19 have been confirmed
- there have now been 25,379 confirmed cases of COVID-19 in Ireland
- validation of data at the HPSC has resulted in the denotification of 1 death - the figure of 25, 379 cases reflect this
