2 deaths and 4 cases confirmed:

- the Health Protection Surveillance Centre (HPSC) has been notified that 2 people diagnosed with COVID-19 in Ireland have died - bringing the total deaths to 1,717
- 4 additional cases of COVID-19 have been confirmed
- there have now been 25,383 confirmed cases of COVID-19 in Ireland
