6 deaths and 5 cases confirmed:

- the Health Protection Surveillance Centre (HPSC) has been notified that 6 people diagnosed with COVID-19 in Ireland have died - bringing the total deaths to 1,726
- 5 additional cases of COVID-19 have been confirmed
- there have now been 25,396 confirmed cases of COVID-19 in Ireland
