The latest news as of 6pm on Thursday 25 June

1 death and 11 cases confirmed:

- the Health Protection Surveillance Centre (HPSC) has been notified that 1 person diagnosed with COVID-19 in Ireland has died - bringing the total deaths to 1,727
- 11 additional cases of COVID-19 have been confirmed
- there have now been 25,405 confirmed cases of COVID-19 in Ireland
- validation of data at the HPSC has resulted in the denotification of 2 confirmed cases. The figure of 25,405 confirmed cases reflects this
