1 death and 3 cases confirmed:

- the Health Protection Surveillance Centre (HPSC) has been notified that 1 person diagnosed with COVID-19 in Ireland has died bringing the total deaths to 1,735
- 3 additional cases of COVID-19 have been confirmed
- there have now been 25.439 confirmed cases of COVID-19 in Ireland

(\*validation of data at the HPSC has resulted in the denotification of 1 confirmed case. The figure of 25,439 confirmed cases reflects this.)
