3 deaths and 6 cases confirmed:

- the Health Protection Surveillance Centre (HPSC) has been notified of 3 additional deaths from COVID-19 in the past 24 hours
- there have been 1,738 COVID-19 related deaths in Ireland
- 6 additional cases of COVID-19 have been confirmed
- there have now been 25,477 confirmed cases of COVID-19 in Ireland
