5 deaths and 15 cases confirmed:

- the Health Protection Surveillance Centre (HPSC) has been notified of 5 additional deaths from COVID-19 in the past 24 hours
- there have been 1,738 COVID-19 related deaths in Ireland
- 15 additional cases of COVID-19 have been confirmed
- there have now been 25,489 confirmed cases of COVID-19 in Ireland
