The latest news as of 7pm on Thursday 2 July

5 deaths and 15 cases confirmed:

- the Health Protection Surveillance Centre (HPSC) has been notified of 5 additional deaths from COVID-19 in the past 24 hours
- there have been 1,738 COVID-19 related deaths in Ireland
- validation of data at the HPSC has resulted in the denotification of 5 deaths. The figure of 1,738 deaths reflects this
- 15 additional cases of COVID-19 have been confirmed
- there have now been 25,489 confirmed cases of COVID-19 in Ireland
- validation of data at the HPSC has resulted in the denotification of 3 confirmed cases. The figure of 25,489 confirmed cases reflects this
