0 deaths and 18 cases confirmed:

- the Health Protection Surveillance Centre (HPSC) has not been notified of any deaths from COVID-19 in the past 24 hours
- there have been 1,741 COVID-19 related deaths in Ireland
- 18 additional cases of COVID-19 have been confirmed
- there have now been 25,527 confirmed cases of COVID-19 in Ireland
