- the Health Protection Surveillance Centre (HPSC) has been notified of 1 death from COVID-19 in the past 24 hours
- there have been 1,743 COVID-19 related deaths in Ireland
- 24 additional cases of COVID-19 have been confirmed
- there have now been 25,538 confirmed cases of COVID-19 in Ireland
