The latest news as of 6pm on Thursday 9 July

6 deaths and 23 cases confirmed:

- the Health Protection Surveillance Centre (HPSC) has been notified of 6 additional deaths from COVID-19
- there have been 1,743 COVID-19 related deaths in Ireland
- validation of data at the HPSC has resulted in the denotification of 1 death. The figure of 1,743 reflects this
- 23 additional cases of COVID-19 have been confirmed
- there have now been 25,565 confirmed cases of COVID-19 in Ireland
