2 deaths and 23 cases confirmed:

- the Health Protection Surveillance Centre (HPSC) has been notified of 2 additional deaths from COVID-19
- there have been 1,746 COVID-19 related deaths in Ireland
- 23 additional cases of COVID-19 have been confirmed
- there have now been 25,611 confirmed cases of COVID-19 in Ireland
- validation of data at the HPSC has resulted in the denotification of 1 confirmed case. The figure of 25,611 reflects this
