0 deaths and 11 cases confirmed:

- the Health Protection Surveillance Centre (HPSC) has not been notified of any additional deaths from COVID-19
- there have been 1,746 COVID-19 related deaths in Ireland
- 11 additional cases of COVID-19 have been confirmed
- there have now been 25,638 confirmed cases of COVID-19 in Ireland
- validation of data at the HPSC has resulted in the denotification of 1 confirmed case. The figure of 25,638 reflects this
