0 deaths and 32 cases confirmed:

- the Health Protection Surveillance Centre (HPSC) has not been notified of any additional deaths from COVID-19
- there have been 1,746 COVID-19 related deaths in Ireland
- 32 additional cases of COVID-19 have been confirmed
- there have now been 25,670 confirmed cases of COVID-19 in Ireland
