2 deaths and 14 cases confirmed:

- the Health Protection Surveillance Centre (HPSC) has been notified of 2 additional deaths from COVID-19
- there have been 1,748 COVID-19 related deaths in Ireland
- 14 additional cases of COVID-19 have been confirmed
- there have now been 25,683 confirmed cases of COVID-19 in Ireland
- validation of data at the HPSC has resulted in the denotification of 1 confirmed case. The figure of 25,683 confirmed cases reflects this
