3 deaths and 34 cases confirmed:

- the Health Protection Surveillance Centre (HPSC) has been notified of 3 deaths from COVID-19
- there have been 1,752 COVID-19 related deaths in Ireland
- 34 additional cases of COVID-19 have been confirmed
- there have now been 25,730 confirmed cases of COVID-19 in Ireland
- validation of data at the HPSC has resulted in the denotification of 2 confirmed cases. The figure of 25,730 confirmed cases reflects this
