- the Health Protection Surveillance Centre (HPSC) has not been notified of any additional deaths from COVID-19 in the last 24 hours
- there have been 1,753 COVID-19 related deaths in Ireland
- 36 additional cases of COVID-19 have been confirmed
- there have now been 25,802 confirmed cases of COVID-19 in Ireland
