1 death and 17 cases confirmed:

- the Health Protection Surveillance Centre (HPSC) has been notified of 1 additional death from COVID-19 in the last 24 hours
- there have been 1,754 COVID-19 related deaths in Ireland
- 17 additional cases of COVID-19 have been confirmed
- there have now been 25,819 confirmed cases of COVID-19 in Ireland
