9 deaths and 7 cases confirmed:

- the Health Protection Surveillance Centre (HPSC) has been notified of 9 additional deaths from COVID-19
- there have been 1,763 COVID-19 related deaths in Ireland
- 7 additional cases of COVID-19 have been confirmed
- there have now been 25,826 confirmed cases of COVID-19 in Ireland
