- the Health Protection Surveillance Centre (HPSC) has been notified of 1 additional death from COVID-19
- there have been 1,764 COVID-19 related deaths in Ireland
- 24 additional cases of COVID-19 have been confirmed
- there have now been 25,869 confirmed cases of COVID-19 in Ireland
