# The latest news as of 5.45pm on Tuesday 28 July

#### 40 cases confirmed:

- the Health Protection Surveillance Centre (HPSC) has not been notified of any additional deaths from COVID-19
- there have been 1,764 COVID-19 related deaths in Ireland
- 40 additional cases of COVID-19 have been confirmed
- there have now been 25,929 confirmed cases of COVID-19 in Ireland
- validation of data at the HPSC has resulted in the denotification of 3 confirmed cases. The figure of 25,929 reflects this
