## The latest news as of 6.30pm on Thursday 30 July

1 death and 85 cases confirmed:

- the Health Protection Surveillance Centre (HPSC) has been notified of 1 additional death from COVID-19
- there have been 1,763 COVID-19 related deaths in Ireland
- validation of data at the HPSC has resulted in the denotification of 2 confirmed cases. The figure of 1,763 deaths reflects this
- 85 additional cases of COVID-19 have been confirmed
- there have now been 26,027 confirmed cases of COVID-19 in Ireland
