- the Health Protection Surveillance Centre (HPSC) has not been notified any additional death from COVID-19 in the past 24 hours.
- there have been 1,763 COVID-19 related deaths in Ireland
- 38 additional cases of COVID-19 have been confirmed
- there have now been 26,065 confirmed cases of COVID-19 in Ireland
