45 cases confirmed:

- the Health Protection Surveillance Centre (HPSC) has not been notified of any additional deaths from COVID-19
- there have been 1,763 COVID-19 related deaths in Ireland
- 45 additional cases of COVID-19 have been confirmed
- there have now been 26,109 confirmed cases of COVID-19 in Ireland
- validation of data at the HPSC has resulted in the denotification of 1 confirmed case. The figure of 26,109 confirmed cases reflects this
