- the Health Protection Surveillance Centre (HPSC) has not been notified of any additional deaths from COVID-19
- there have been 1,763 COVID-19 related deaths in Ireland
- 53 additional cases of COVID-19 have been confirmed
- there have now been 26,162 confirmed cases of COVID-19 in Ireland
