## The latest news as of 6.45pm on Thursday 6 August

### 5 deaths and 69 cases confirmed

- the Health Protection Surveillance Centre (HPSC) has been notified of 5 additional deaths from COVID-19 (4 of these deaths are late notifications of deaths that occurred in April and June)
- there have been 1,768 COVID-19 related deaths in Ireland
- 69 additional cases of COVID-19 have been confirmed
- there have now been 26,372 confirmed cases of COVID-19 in Ireland
