4 deaths and 98 cases confirmed

- the Health Protection Surveillance Centre (HPSC) has been notified of 4 additional deaths from COVID-19
- the 4 deaths notified are from May, June, July and August
- there have now been 1,772 COVID-19 related deaths in Ireland
- 98 additional cases of COVID-19 have been confirmed
- there have now been 26,470 confirmed cases of COVID-19 in Ireland
