1 deaths and 174 cases confirmed

- the Health Protection Surveillance Centre (HPSC) has been notified of 1 additional death from COVID-19
- there have now been 1,772 COVID-19 related deaths in Ireland *(1 case was denotified)
- 174 additional cases of COVID-19 have been confirmed
- there have now been 26,644 confirmed cases of COVID-19 in Ireland
