## The latest news as of 5.45pm on Saturday 8 August

1 deaths and 174 cases confirmed:

- the Health Protection Surveillance Centre (HPSC) has been notified of 1 additional death from COVID-19
- there have been 1,772 COVID-19 related deaths in Ireland
- validation of data at the HPSC has resulted in the denotification of 1 death. The figure of 1,772 reflects this
- 174 additional cases of COVID-19 have been confirmed
- there have now been 26,644 confirmed cases of COVID-19 in Ireland
