## The latest news as of 5.45pm on Tuesday 11 August

1 death and 35 cases confirmed:

- the Health Protection Surveillance Centre (HPSC) has been notified of 1 additional death from COVID-19
- there have been 1,773 COVID-19 related deaths in Ireland
- 35 additional cases of COVID-19 have been confirmed
- there have now been 26,801 confirmed cases of COVID-19 in Ireland
- validation of data at the HPSC led to the denotification of 2 confirmed cases. The figure of 26,801 confirmed cases reflects this
